### BOARD OF REVIEW --- May 4, 2020

The 2020 Board of Review meeting was convened on May 4, 2020 at the Town of Baraboo Town Hall, and called to order at 6:32 PM. The Town Clerk, Morgan Olson, verified that the meeting was properly posted.

Roll call was taken. Present were: Clerk, Morgan Olson; Supervisors Steve Hess, Paul Hasheider, and Mike Terry; and Assessor, Craig Olson from Associated Appraisal Consultants, Inc.

Chairperson Steve Hess asked which members were certified by the State. Clerk Morgan Olson reported that Paul Hasheider, Mike Terry, and Morgan Olson were certified.

Chairperson Steve Hess asked if the Assessment Roll was signed by the Assessor. Assessor Craig Olson certified and signed the Assessment Roll. Clerk Morgan Olson verified the assessment roll had been signed.

Chairperson Steve Hess asked if the notices had been sent out 15 days prior to the Board of Review. Assessor Craig Olson stated that all notices had been sent out by the assessor 15 days prior to Board of Review.
