1. Call the meeting to order and take a roll call of the town's elected officials present.
2. Verify compliance with Wisconsin's open meeting laws.
3. Recite the Pledge of Allegiance.
4. Discussion and possible action regarding adoption of this meeting's agenda.
5. Discussion and possible action regarding approval of the minutes of the regular town board meeting held on March 13, 2023.

7. Citizens' appearance; any person wishing to speak about a subject that is **not** on this agenda may make a short presentation to the town board. Please keep the presentation respectable and to-the-point.
8. Discussion and possible action regarding approval of a Certified Survey Map application to combine two 0.08-acre parcels into one 0.16-acre parcel from owner Jonathan Wetzel and applicant Kerry Zimmerman of MSA Professional Services, Inc., on tax parcels 002-1205-00000 and 002-1206-00000, located at E11646 and E11652 Lakewood Park Road. The proposal is to be discussed at the Town of Baraboo Plan Commission meeting immediately preceding this town board meeting.
9. Discussion and possible action regarding selection of a time and date for the initial 2023 Board of Review. The initial BOR meeting must be completed within 45 days after the fourth Monday in April; since the revaluation is not scheduled to be completed within this period, the board must meet to adjourn to a later date.
10. Discussion and possible action regarding selection of a time and date for the reconvened 2023 Board of Review. The 2023 Assessment Roll is scheduled to be ready by late July or early August.
