# AMENDMENTS TO THE CODE OF ORDINANCES TOWN OF BARABOO, SAUK COUNTY, WISCONSIN CHAPTER 39, "ALL-TERRAIN & UTILITY TERRAIN VEHICLE ROUTE"

The Town Board of the Town of Baraboo, Sauk County, Wisconsin, has the specific authority, under Sections § 23.33(4)(d)4 and § 23.33(11) of the Wisconsin Statutes and Section 39.06 Subsection B of the Town of Baraboo Code of Ordinances, to adopt this amendment to the Code of Ordinances of the Town of Baraboo.

This amendment to the Code of Ordinances, adopted by a majority vote of the town board on a roll call vote with a quorum present and voting and proper notice having been given, amends Chapter 39 of the Code of Ordinances and Ordinance 2022-3 by adding, removing, or altering as follows:

**SECTION 39.06** 

## DESIGNATION OF ALL-TERRAIN VEHICLE & UTILITY TERRAIN VEHICLE ROUTES

#### A. ROADS DESIGNATED

- 1. The Town of Baraboo hereby designates all town roads, except the roads listed by name in Subsection 2, as Regular All-Terrain Vehicle and Utility Terrain Vehicle Routes:
- 2. The Town of Baraboo hereby designates the following town roads as Restricted All-Terrain Vehicle and Utility Terrain Vehicle Routes, to be utilized only by residents of these roads to access Regular All-Terrain Vehicle and Utility Terrain Vehicle Routes:
  - a) Birnam Woods Road
  - b) Breezy Knoll Lane
  - c) Crawford Street (From Goerks Road south to City of Baraboo line)
  - d) Gasper Drive
  - e) Glacier Drive
  - f) Granite Lane
  - g) Mammoth Trail
  - h) Pine Acres Drive
  - i) Whispering Pines Drive
  - j) West Wynsong Lane
  - k) Wynsong Drive

This ordinance shall take effect upon adoption by the Town Board of the Town of Baraboo after posting and publication, as required by law.
